OVERVIEW

Until recently, parties who had yet to appoint the arbitration tribunal were only able to seek urgent interim relief from a court. Emergency arbitration is now a feature of the rules of all leading international arbitration institutions, including KLRCA and SIAC, and is likely to remain a permanent part of the international arbitration landscape. This talk will provide an overview on the emergency arbitration process and award.
